



Terms & Conditions Governing the FRANK X MPL Season 5 MLBB Debit Card Online Acquisition Promotion (the “Promotion”)

Promotion Period

1. The promotion period shall run from 13 March 2023 to 7 May 2023 (both dates inclusive), or such other periods(s) as may be determined by Oversea-Chinese Banking Corporation Limited (“OCBC Bank”) at its absolute discretion (the “Promotion Period”).

Eligibility

2. This Promotion is applicable to individuals who meet all the following conditions (“Eligible Cardmember”):
 - a. you are a new FRANK Debit Cardmember who (i) currently does not hold an existing FRANK Debit Card, and (ii) has not held FRANK Debit Card in the previous six (6) months, and has successfully signed up for a FRANK Debit Card during the Promotion Period, where such application was made online through the relevant application link in <https://www.frankbyocbc.com/campaign/mps5-2023> (“**New Card Applicant**”).
 - b. Applicants who had cancelled existing FRANK Debit Card facilities within the last six (6) months prior to the commencement of the Promotion and re-applied for such facilities under the Promotion are not eligible to participate in the Promotion;

Limited-edition MLBB Card Designs

3. New Card Applicants will be eligible to choose one of six limited-edition FRANK X MPL Season 5 MLBB Debit Card designs. The limited-edition MLBB card designs will only be available for the first card issued to the New Card Applicant. Any replacement or renewal of the FRANK Debit Card will be defaulted to ART0014 – Resurgence card design. Replacement or renewal cards for customers who currently hold MLBB card designs from MPL SG Season 2 will also be defaulted to ART0014 – Resurgence card design.
4. Notwithstanding clause 3, the provision of any FRANK Debit Card and/or card design is subject to availability and is at OCBC Bank’s sole discretion.
5. Card designs may be subject to intellectual property rights or other proprietary rights belonging or licensed to OCBC Bank and/or any third party. No title, license, right or interest over any card design (and/or any intellectual property right or other proprietary right subsisting therein) shall be deemed to be granted to the customer, and the customer shall comply with any instructions, guidelines and/or restrictions relating to such use of the card designs as may be prescribed by OCBC Bank from time to time.

General

6. The eligibility of any Eligible Cardmember to participate in this Promotion shall be determined at the absolute discretion of OCBC Bank.



7. OCBC Bank reserves the right at its absolute discretion to terminate the Promotion or vary, delete, or add to any of these terms and conditions at any time without notice including without limitation, the eligibility of any customer and the dates of the Promotion.
8. OCBC Bank shall not be responsible for the quality, merchantability or fitness for any purpose or any other aspect of the Promotion, or any product and/or service relating to the Promotion. Notwithstanding anything herein, OCBC Bank shall not at any time be responsible or held liable for any defect or malfunction in any product or the deficiency in any service provided, and/or any loss, injury, damage or harm suffered or incurred by or in connection with the Promotion, and/or the use of any product and/or service relating to the Promotion, by any person.
9. OCBC Bank's decisions on all matters relating to the Promotion shall be final and binding on all participants. No correspondence or appeal shall be entertained by OCBC Bank. In the event of any inconsistency between these terms and conditions and any brochure, marketing or promotional material relating to the Promotion, these terms and conditions shall prevail.

OCBC Bank shall not be responsible for any loss or damage to any person in connection with the Promotion howsoever arising, including any error in computing chances, any breakdown or malfunction in any computer system or equipment, or any notice which is misdirected or lost in the post or in transmission.
